SCHOOL OF APPLIED TECHNOLOGY

The goal of the School of Applied Technology is to train students for positions in entry-level vocations. Programs are designed to provide individualized, hands-on, competency-based instruction. The openentry/open-exit enrollment feature allows students to start programs on a weekly basis and complete when they have mastered the competencies supported by business and industry.

In 2007-2008, the School of Applied Technology served 1,887 students for a cumulative total of 414,105 clock hours of instruction. Of these students:

- 948 were female (50.2%)
- 931 were male (49.3%)
- 8 did not report gender (.5%)

CURRENT BUDGET

The total appropriated operating budget for 2008-09 is more than \$111 million. (*This figure represents the original budget before legislative budget cuts.*)

Appropriated revenues come from two major sources: state funds and dedicated credits. Other sources account for the residual.
