THREE WORKSHOPS PLANNED

Vice-president for Instruction Max Lowe announces three workshops planned for faculty and instructional staff prior to fall quarter.

Pat Latham is chairing a committee planning a one-week New Teachers workshop in September. And Geoff Brugger is chairperson for a two-day Fall gathering for all teachers. These meetings will be spaced so that new instructors will have the opportunity of attending the fall instructional seminar. The fall educational meetings will not duplicate New Teacher workshop subjects.

Additionally, Gary Cole is heading a committee putting together a Management workshop, designed particularly for instructional deans, etc.

It is anticipated further details will be given as soon as they are firmed up.

UTAH TECH PUBLICATIONS DUE SOON

The long-awaited 1981-82 UTC catalog should be delivered within a week.

The publication reflects the input of Admissions Consulting Services, a consulting firm headed by Dr. Thomas LaBaugh, of Grand Rapids, Michigan.

The cover, with the theme "Dare to Soar," will be repeated in a number of other college publications designed for student use. The unity of the single cover idea will help provide instant recognition of Utah Tech in the minds of thousands of potential students mulling the advantages of attending this institution.

In addition to the variety of print materials bearing the "Dare to Soar" theme, the fall quarter schedule has now been printed on campus. The latter publication is handled by thousands of students seeking appropriate classes tying-in with their individual majors.

'CRITICAL INDUSTRIES' MONEY AWARDED UTAH TECH

Utah State Board for Vocational Education has awarded some \$94,000.00 to the college to advance programs needed critically in the state.

For example, part of the money will be used for additional resources in the Heavy Duty Mechanics program. And some air conditioning classes will be taught in conjunction with the institution's Electricity program.

Further, it is anticipated that an Industrial Maintenance program will be started, providing urgently needed manpower in the state for this important work.

THREE TELECOURSES OFFERED THROUGH UTAH TECH

Fall quarter will see the External Programs division of the college offering three exciting telecourses. Course titles include "Humanities through the Arts," "Contemporary Health Issues" and "The American Story: The Beginning through 1876."

Dean Verlaine McPhie notes that the classes each provide 3 credits, acceptable toward the Associate in Applied Science degree general education requirements.

Registration takes place during the month of September. Tuition and fees for each course is \$81.

The programs are part of a national tele-schedule, bearing the trade mark "Give Yourself Some Credit."

STUDENTS MAKE PRESENTATION TO INSTITUTIONAL COUNCIL

Student body president Cal Corbridge, a member of the college's Institutional Council, was scheduled to make a presentation before that group, Wednesday, August 19th, requesting the council's consideration of transferability of credits.

Executive vice-president Paul Hicken and vice-president for publications Kirk McElroy were to be available, also, for further input as needed.

Student body officers note that many times a 4-year institution will automatically approve 'Junior' status to a graduate of a 2-year college awarded an Associate in Science degree. Student officers are concerned that the same approval does not come with an A.A.S. degree. Their desires are to encourage the Institutional Council to work with the Regents to get the A.S. degree approved for UTC/SL as soon as practicable.

UTAH TECH STUDENTS PARTICIPATE IN NATIONAL LEADERSHIP CONFERENCE
